Description

Residential customers can save money and reduce their water use through a variety of rebates provided through the SoCal WaterSmart Residential Rebate Program, jointly implemented by LADWP and the Metropolitan Water District of Southern California (MWD).

Benefits

Water is a critical part of life. In L.A., our water supply is limited. We can help make the most of it by using water wisely everyday, both indoors and outdoors.

- 🏠 You can save 16 gallons per load if you install a high efficiency clothes washer.
- 🏠 You can save 21 gallons per day if you install a high efficiency toilet.
- 🏠 You can save up to 15-30 gallons per day if you install a water efficient irrigation system with rotating nozzles or a weather-based irrigation controller.

Qualifications

Go to www.ladwp.com/rwr for current rebate amounts and qualifying models. Only one rebate application per product category, per customer. Rebates are only paid to the customer of record. All rebates are paid on a one-time per address basis and are subject to inspection.

Details

Below are the current residential rebates:

High Efficiency Clothes Washer: Qualifying washers must meet or exceed the CEE Tier 1 standard.	Up to \$500
Premium High Efficiency Toilet: Must upgrade from 1.6 gallons per flush (gpf) or greater to a 1.1 gpf or less.	Up to \$250
Turf Replacement Program: Pre-approval application required before starting project. Get paid to remove current grass and replace it with a California Friendly landscape, mulch and permeable hardscape. To apply, visit: www.socalwatersmart.com	\$5.00 per square foot of grass removed for a maximum of 5,000 square feet
Weather-Based Irrigation Controller: Qualifying controller for less than one acre is \$200; greater than or equal to one acre the rebate is \$35 per station.	\$200 < 1 acre \$35 per station ≥ 1 acre
Rotating Nozzles: Qualifying nozzles must be purchased in a minimum of 30 nozzles to qualify for rebate.	Up to \$6 per nozzle
Rain Barrel or Cistern: Each household may qualify for a rebate for up to two 50-gallon rain barrels or one cistern. Cisterns (200-500 gallons) \$300; (501-999 gallons) \$400; or (1000+ gallons) \$500. Rebates are for either the rain barrel(s) or cistern and may not be combined.	Up to \$50 per rain barrel (max 2); or up to \$500 per cistern (max 1)
